Integrated Pest Management (IPM) Overview

Food processing, manufacturing, and distribution plants inherently face the risk of attracting pests due to the favorable conditions they offer—abundant food, water, and shelter. Maintaining a pest-free environment within these facilities is essential to mitigate the detrimental impact that pests can incur. The impact encompasses the spread of pathogens, product spoilage and waste, deterioration of critical areas, and incalculable damage to a brand's reputation.

The Food Safety Modernization Act of 2011 is shifting from a reactive approach to a proactive one through a process of scientifically grounded hazard analyses and a regimen of preventive controls.

IPM aligns with this proactive approach by focusing on the strategies of prevention, monitoring, and targeted treatments. The 6 Principles of IPM

1. Monitoring

• Regular site inspections and trapping to determine pest type and pressure

2. Record-Keeping

• Cataloging pest activity to establish trends and efficacy of corrective actions

Documentation of control measures

3. Action Levels

Establish practical thresholds for each pest type

4. Prevention

Alert client to pest conducive conditions

• Educate client on how to exclude and discourage pests

5. Tactics

- Exclusion
- Sanitation
- Habitat modification
- Targeted treatment

6. Evaluation

• Regular re-evaluation of the IPM program in response to pest pressures, trends, and altering environments

By understanding why a pest is in your facility, we can design a holistic approach to eliminate it.

Flies:



Flies in a food facility are more than an annoyance; they can lead to regulatory non-compliance, audit failure, product waste, and most troublingly, they can act as vectors of pathogens responsible for diseases like dysentery, gastroenteritis, and salmonella. Given their ability to move between decaying substances where they breed, and food preparation areas, flies pose a tangible threat to health. Understanding the type of fly is key to achieving control. Large flies often enter as incidental invaders, whereas small flies are more likely to develop inside of the facility. Correctly identifying the fly species determines the proper course of action. Our ABC Home & Commercial Services IPM specialists will customize a program for the fly at-hand while working with you to understand and eliminate potential breeding sites to achieve safe, potent, and lasting management.

Rodents:



Rats and mice, notorious for carrying an array of bacterial and viral pathogens, are the most commonly known cause of food adulteration by way of product consumption, contamination, damage, and deterioration of critical environments. The very nature of food processing and manufacturing plants, with food odors, warmth, and water, provides an ideal environment for commensal rodent success, with distribution centers and warehouses also being vulnerable due to multiple doors and high throughput. A rodent infestation can result in heavy losses, regulatory non-compliance, and audit failure. To counter this threat, ABC Home & Commercial Services offers a three-pronged IPM program of exclusion, interior trapping, and exterior baiting. Our IPM specialists will also work with you to identify the source of the problem and to recognize the resources that attract rodents to your facility in the first place. When utilizing a combined approach of reinforcing physical barriers to entry, trapping and baiting, and reducing access to critical resources, sustainable rodent control is possible.

Cockroach & Crawling Insects:



Food processing and manufacturing facilities provide an optimal combination of warmth, moisture, sustenance, and numerous harborage points for cockroaches and other crawling insect infestations. Successful management begins with a comprehensive inspection and proper identification. Our IPM specialists will monitor and identify the problem pest then utilize targeted and appropriate treatments to gain control. ABC Home & Commercial services will work with you to identify and eliminate the source of the problem with the ultimate goal of preventing future occurrences.

Stored Product & Textile Insect Control:



Stored product pests can have a significant economic impact on your bottom line due to product loss from direct feeding, contamination with insect frass, and quality deterioration with off-odors and flavors. In addition, there can be intangible losses from customer complaints and a carefully nurtured reputation can be damaged with one infestation. Therefore, the need to get ahead of a potential infestation is paramount. ABC Home and Commercial Services carefully monitors your susceptible products with a custom fit system of pheromones lures and traps, and at the first signs of an emerging issue can select a remediation method best suited to the environment and insect. These methods can include mating disruption, insect growth regulators, fogging, and fumigation. We can also assist with non-chemical means of control such as identifying infested product for removal, and sanitation and exclusion recommendations to rapidly curtail the potential for spread.

Termites:



Subterranean termites are some of the most destructive pests of wood in the world. In Texas alone, they cause around \$500 million worth of damage to properties every year by attacking the cellulose in wood components of structures, causing them to become brittle and weak. Termite control is specialized work requiring knowledge in properly performing inspections, recognizing signs of activity, identifying the termite species, and applying the correct treatment. Rest assured that all of our IPM professionals have undergone extensive training and have been licensed by the State of Texas specifically for termite and wood-destroying insect control.

Pest Bird Control:



A bird becomes a pest when it poses a threat to human or animal health or to the local ecology. They can also wreak economic damage to property, buildings, and crops. The most common pest birds around food processing facilities are pigeons, sparrows, and starlings. These species will often roost on or in structures and in doing so spread pathogens through the waste that they deposit and the nesting material they collect. Our IPM specialists can build and enact a program to exclude, repel, or remove these pest birds and the challenges they create.
